- ❖ Closing date for Registration and full or part payment is 31st March
- ❖ Parents wishing to accompany their children should obtain further Information from the contact persons listed at the enquiry column.
- ❖ An additional sum of £300 is advised to be given to the participating child as pocket money to take care of the extras e.g. Ice cream, drinks, souvenir purchases not covered by the tour cost.
- ❖ All children must be dewormed and investigated for Malaria/Typhoid at least one week before departure date and any failure to do so which results in such disease manifesting after departure, the sponsoring parent(s) shall be debited for any medical expenses incurred on account of such child(ren).
- ❖ No cancellations are allowed after registration or closing date and where sought, the cancellation charge of 45% of the total purchase cost will become deductible by the
- ❖ Operators. If Visas have been obtained for the child or person at the time cancellation is requested, the Operators shall retain the passport of such participants until the expiration of the visas.
- ❖ Visa application requirements will require that parents be ready to oblige the Operators and bring along all originals of supporting documentation on the date of the interview, a list of which may be obtained from the operators upon registration.
- ❖ A copy of the British visa application forms and requirements for the country to be visited are to be obtained upon return of the Registration Form. Any special visa interview dates will be communicated to parents as the occasion demands.
- ❖ Please note that in the unforeseen event of a participant's failure to secure a visa through no negligence of the operators, 15% of the total sum paid in respect of such child(ren) shall be retained by the Operators as deemed cancellation charges.
- ❖ The Operators reserve the right to change, cancel or postpone without notice or liability to participant, or their sponsors any tour or part thereof already advertised provided always that if the cancellation or change affects only a part of the advertised tour then the participants shall not be entitled to a refund of the cancelled part but the company shall in its absolute discretion consider to be alternate and/or commensurate to the part cancelled or changed AND if visas have already been obtained for such cancelled tour the visa application fee and 20% of the tour will not be refunded to participant.
